April is Child Abuse Prevention Month

April 17, 2010: 4:30-7:00 PM; Mabel Woolsey Carnival in Knoxville.

April 19, 2010: 2:00 PM; Placing 100 pinwheels on center strip in Knoxville. The pinwheels represent 229 confirmed cases of child abuse in Knox County in 2009.

April 22, 2010: 4:00 PM; Hands Around the Courthouse at the Knox County Courthouse. Guest speaker will be Carol St. Amant.

Look for child abuse prevention bookmarks, buttons, and blue ribbons at local businesses.

Also, Knox County children are participating in a poster contest sponsored by the Blue Ribbon Task Force and the Exchange Club of Galesburg. Beginning April 1st, the posters will be on display at the Galesburg Public Library. The community is invited to view the posters throughout the month and to vote for their favorites. Winners will be announced May 1st on Safe Harbor's website (<u>www.safeharbordv.org</u>). Posters will be used to create placemats that will be used in several restaurants throughout our county. Special thanks to the Exchange Club for their contributions to the Blue Ribbon Task Force.

The Blue Ribbon Task Force consists of representatives from Knox County social service agencies, including: Bridgeway, CASA of Knox County, Family Planning Services/Initiative for Girls, Knox County Area Project, Knox County Teen Court, Safe Harbor Family Crisis Center, and University of Illinois Extension.

Calling All Cell Phones

Deactivated cell phones, utilized as 9-1-1 phones, are a vital service for Safe Harbor clients. They increase safety as well as peace of mind. Upon request, they are given free-of-charge to our clients. However, our inventory fluctuates on a daily basis. Therefore, we are putting an "all-points bulletin" out for used cell phones.

Safe Harbor accepts all types of used cell phones. We do ask that, if at all possible, the chargers be included.

This way they can be kept fully charged and ready to go. Moreover, we even accept broken and analog cell phones!
